# PATENTS





### **REQUIREMENTS**

#### **SEARCHES**



Non-official searches are not possible.

Official searches are available.

Limited to published and granted patents.

Search by applicant details, application number/date, grant date, title of invention.

### At the time of filing:

- Applicant and inventor details in English and Arabic.
- Title of Invention and Abstract in English and Arabic.
- Specification, claims and drawings in English.
- International Status Report (for PCT applications).

# FILING REQUIREMENTS



Arabic translation of all documents is required.

The original documents are required.

#### Within 60 days of filing\*:

- Specification, claims and drawings in Arabic.
- Power of Attorney, legalised to the embassy of Jordan.
- Certified copy of Certificate of Incorporation or Commercial Extract if applicant is a company.
- Affidavit(s) of patent ownership, legalised to the embassy of Jordan.
- Certified copy of the Priority
   Document in English with its Arabic translation, if priority is claimed.

\*If the documents are not ready - an extension of time is possible.

# PRIORITY CLAIM(S)



Priority must be claimed at the time of filing.

12 month Paris Convention priority period.

# TYPE OF EXAMINATION



Formal examination.

Substantive examination.

### **PUBLICATION**



Patents are published in the official gazette before grant (once accepted).





### **REQUIREMENTS**

### **OPPOSITIONS**



Third parties may oppose the grant of a patent within 3 months of publication in the official gazette.

## PROTECTION TERM



Patents expire 20 years from the national filing date for Non-PCT filings (or the international filing date if the application is a PCT-national phase application) provided all annuities are paid.

### CHANGE OF NAME AND/OR ADDRESS



Changes of name and/or address may be recorded against applications and registrations.

The original documents are required.

Power of Attorney, legalised to the embassy of Jordan.

Change of name/address declaration legalised to the embassy of Jordan.

### **ASSIGNMENTS**



Assignments may only be recorded against applications and registrations.

Assignments should be published to take effect.

The original documents are required.

- Power of Attorney, legalised to the embassy of Jordan.
- Deed of Assignment, legalised to the embassy of Jordan.
- Certified copy of Certificate of Incorporation or Commercial Extract if applicant is a company.

#### **ANNUITIES**



Annuities must be paid every year on the anniversary of the filing date (or the international filing date if the application is a PCT-national phase application).

There is a 6-month grace period for late payment of annuities (penalty fees apply).

### REQUIREMENTS

### **SEARCHES**



Non-official and official searches are possible.

Limited to published and granted designs

Search by applicant details, application number/date, grant date, title of design.

### At the time of filing:

- Figures in English.
- Description of design in English and Arabic.
- Description of figures in English.
- Applicant(s) and designer(s) details in English and Arabic.

### Within 60 days of filing\*:

- Figures in Arabic.
- Description of figures in Arabic.
- Power of Attorney, legalised to the embassy of Jordan.
- Certified copy of Certificate of Incorporation or Commercial Extract if applicant is a company, legalised to the embassy of Jordan.
- Deed of Assignment, legalised to the embassy of Jordan.
- Certified copy of the Priority
   Document in English with its Arabic translation, if priority is claimed.

\*If the documents are not ready - an extension of time is possible.

# FILING REQUIREMENTS



Arabic translation of all documents is required.

The original documents are required.

### MULTIPLE DESIGN FILING SYSTEM



Yes - up to 14 homogeneous designs.

Each design official fee must be paid.

# PRIORITY CLAIM(S)



Priority must be claimed at the time of filing.

6 month Paris Convention priority period.

### **EXAMINATION**



Formal examination only.

## **PUBLICATION**



Designs are published in the official gazette before grant (once formally accepted).





### **REQUIREMENTS**

### **OPPOSITIONS**



Third parties may oppose the grant of a patent within 90 days of publication in the official gazette.

## PROTECTION TERM



Design protection is valid for 15 years from the earliest filing date or priority date, if earlier.

### CHANGE OF NAME AND/OR ADDRESS



Changes of name and/or address may be recorded against registrations.

The original documents are required.

- Power of Attorney, legalised to the embassy of Jordan.
- Change of name/address declaration legalised to the embassy of Jordan.
- Copy of the design/renewal certificate.

### **REQUIREMENTS**

# PROTECTION TERM



If the application is claiming priority, the protection term calculated from the filing date of the priority application.

Registrations can be renewed every 10 years in perpetuity.

### USE REQUIREMENT



Marks may become vulnerable to cancellation after 3 years of non-use.

### CHANGE OF NAME AND/OR ADDRESS



Changes of name and/or address may be only recorded against trade mark registrations and not pending applications.

- A legalised Power of Attorney.
- A simple copy of the latest trade mark registration or renewal certificate.
- A legalised change of name and/or address declaration.
- Late filing of the supporting documents is possible.

### **ASSIGNMENTS**



Assignments may be only recorded against trade mark registrations and not pending applications.

- A legalised Power of Attorney from the assignee.
- A simple copy of the latest trade mark registration or renewal certificate.
- A legalised Deed of Assignment.
- Late filing of the supporting documents is not possible.

### **RENEWALS**



Trade mark registrations are due for renewal within a 10 years period calculated from the filing date/priority date of the application.

The renewal grace period is 1 year.

- A legalised Power of Attorney.
- A simple copy of the latest trade mark registration or renewal certificate.
- Late filing of the supporting documents is not possible.
